

STUDENT LOAN FORGIVENESS

On August 26, 2022, the Biden Administration announced an executive action to forgive \$20,000 of student loan debt for Pell Grant recipients and \$10,000 of student loan debt for borrowers who make up to \$125,000 a year. Families with an annual income up to \$250,000 will also benefit from the loan forgiveness.

The executive action also extended the pandemic pause on student loan payments through the end of the year. Intially, loan payments for millions of borrowers were set to resume after August 31. Debt relief will not count as taxable income for federal income tax purposes.

The loan forgiveness will apply federal student acquired by undergraduates, graduates, and parents. The forgiveness should happen automatically for 8 million borrowers whose income information is already available to the Department of Education because of income-based repayment plans. For others, the Department is in the creating process of streamlined application form.

Details on proceeding for all borrowers will be available in the coming weeks. Due to the influx of scammers, All borrowers are cautioned to be on high alert!

Title IX: Facts You Should Know



Title IX is a federal civil rights law passed as part of the Education Amendments of 1972. It followed the passage of the Civil Rights Act of 1964, which prohibits discrimination in employment and public accommodations based on race, color, religion, sex, or national origin. Significantly, the Civil Rights Act of 1964 did not address discrimination against persons employed at educational institutions.

A similar law, Title VI, was enacted in 1964 to prohibit discrimination in federally funded private and public entities. This act covered race, color, and national origin but excluded sex. During the 1970s, lobbyists compelled Congress to add gender as a protected class category. Title IX law was enacted to fill this gap and prohibit discrimination in all federally funded education programs. This year, Title IX Celebrates its 50th Anniversary with key changes in the proposed amendments.

The Title IX Program was signed into federal law in 1972 to prohibit gender-based discrimination against students and employees of educational institutions receiving federal financial aid assistance. Title IX also prohibits sexual harassment, inclusive of any act of sexual assault or sexual violence.

Schools must appoint a Title IX Coordinator to oversee their institution's Title IX compliance efforts. HBC is committed to maintaining a learning and work environment where all individuals are treated with respect and dignity. Presently, three staff members oversee and manage the College's compliance efforts. More information is available on the College website.
