# 2022-2023 Independent Verification Worksheet

Your 2022-2023 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA. In this process, the school will be comparing information from your application with you and your spouse's 2019 Federal tax transcripts, wage and income transcript or other financial documents. If there are differences your FAFSA information may need to be corrected. You and your spouse whose information was reported on the FAFSA must complete this institutional verification document, attach any required documents, and submit the form and other required documents to the Financial Aid office. We may ask for additional information if necessary. If you have questions about verification, contact us as soon as possible so that your financial aid will not be delayed.
